ARTICLES OF INCORPORATION OF LAY BLOCKS INC.

ARTICLE ONE

The name of this corporation is: LAY BLOCKS INC.

The principal office and mailing address of this corporation is: 1200 NW 78 Avenue-Ste. #216, Miami, Fl. 33126

ARTICLE TWO

NATURE OF BUSINESS

This corporation may engage in any activity or business that are permitted under the laws of the United States of America and the laws of the State of Florida.

ARTICLE THREE

DURATION

This corporation shall have perpetual existence unless sooner dissolved in accordance with the laws of the State of Florida. The date on which corporate existence shall begin is: UPON APPROVAL BY SECRETARY OF STATE.

BY LAWS
