ARTICLES OF INCORPORATION OF STRINGFELLOW OPEN STORAGE, INC

The undersigned incorporator, for the purpose of forming a corporation under the Florida Business Corporation Act, hereby adopts the following Articles of Incorporation.

ARTICLE I NAME

The name of the corporation shall be STRINGFELLOW OPEN STORAGE, INC.

ARTICLE II PRINCIPAL OFFICE

The street address of the principal office is 8043 Barrancas Avenue, Bokeelia, Florida 33922, and mailing address of this corporation shall be 8043 Barrancas Avenue, Bokeelia, Florida 33922.

ARTICLE III CAPITAL STOCK
