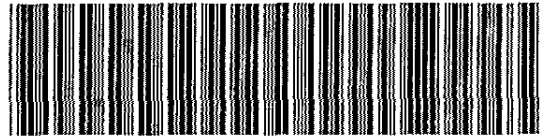

ARTICLE I

Name

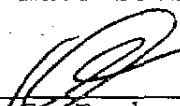
ARTICLE IX

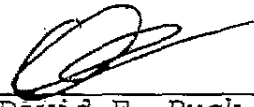
