**ARTICLES OF INCORPORATION
OF

ARTICLE I - NAME AND PRINCIPAL ADDRESS

The name of the corporation is LJR INVESTMENTS GROUP, INC., and the principal address and principal place of business is 8319 40TH PLACE NORTH, ST. PETERSBURG, FLORIDA 33709.

ARTICLE II - REGISTERED OFFICE AND AGENT

ARTICLE VII - INCORPORATOR


