Executed by the undersigned for the purpose of forming a for profit corporation in compliance with Chapter 607 and/or Chapter 621, F. S. (Profit):

#### ARTICLE I

The name of this corporation is Bob Shauan Pools, Inc. The principal place of business and mailing address of the Corporation is 357 South Seneca Blvd. Daytona Beach, FL 32114.
