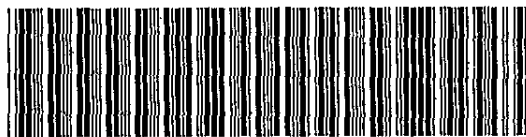

Article I
