ARTICLES OF INCORPORATION

THE STATE OF FLORIDA
TALLAHASSEE, FLORIDA

OF

MICROSURE INSPECTIONS, INC.

The undersigned, for the purpose of forming a corporation under the Florida Business Corporation Act, do hereby adopt the following Articles of Incorporation:

ARTICLE 1.0 NAME AND ADDRESS

The name of the Corporation is Microsure Inspections, Inc. The principal office and mailing address is 400 Madison Avenue, #104, Orange Park, Florida 32065.

ARTICLE 2.0 DURATION

The duration of the Corporation is perpetual.

ARTICLE 3.0 PURPOSE

The general purpose for which the Corporation is organized is to engage in and transact any lawful business for which corporations may be incorporated under the Florida General Corporation Act. No other purpose limits this general purpose in any way.

ARTICLE 4.0 SHARES

The aggregate number of shares which the corporation is authorized to issue is One Hundred Thousand (100,000) shares of common stock which shall be of a single class with regard to all rights except voting rights. Ninety Thousand (90,000) shares shall be non-voting and Ten Thousand (10,000) shares shall be voting. All shares shall have a par value of .01/100 per share.

ARTICLE 5.0 INITIAL REGISTERED OFFICE AND AGENT

The street and mailing address of the initial registered office of the Corporation is 7785 Baymeadows Way, Suite 107, Jacksonville, Florida, 32256, and the name of the initial registered agent at that address is Todd Watson, Attorney at Law.


ARTICLE 8.0 AMENDMENT


