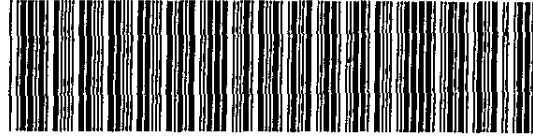

ARTICLES OF INCORPORATION OF ***Mysyk's, Incorporated***

ARTICLE I. NAME

The name of the corporation is:

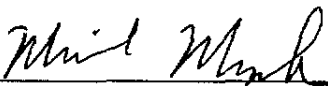
