ARTICLES OF INCORPORATION

OF

CRO MEDICAL, INC.

ARTICLE I

The name of the corporation is CRO Medical, Inc., (hereinafter called the "Corporation").

ARTICLE VIII

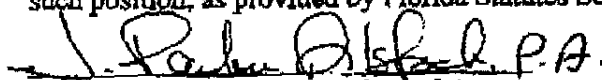
The effective date of the filing of these Articles of Incorporation shall be November 05, 2004.
