





# ARTICLES OF INCORPORATION OF TOFTEC Inc.

The undersigned, for the purposes of forming a corporation under the Florida General Corporation Act, FS Chapter 607 and/or Chapter 621, do hereby adopt the following articles of incorporation:

#### ARTICLE I NAME

The name of the corporation shall be: TOFTEC Inc.

#### ARTICLE II PRINCIPAL OFFICE
