

CORPORATION MINUTES OF SHARE HOLDER'S MEETING

December 17, 2004

This document is intended to reflect the corporate minutes of said shareholder's meeting for The Zone Art Lounge, Inc., a Florida Corporation, held on December 17, 2004.

-It is at this time Corporate Office/Director, James M. Dreher, whose post office address is 6234 Grand Boulevard, Suite 204, New Port Richey, Florida 34652, wishes to rescind his mistaken resignation as a Director of The Zone Art Lounge, Inc. James M. Dreher purports that said resignation was made in error and it has never been his intention to resign from his position as a Director of The Zone Art Lounge, Inc. By virtue of said reinstatement of James M. Dreher as Director of The Zone Art Lounge, Inc., both James M. Dreher and Dustin O. Dreher shall both be listed as Directors of The Zone Art Lounge, Inc, with no ownership of shares and no voting rights of said corporation.

-As 100% share holder of The Zone Art Lounge, Inc. Jim Dreher, Inc. has determined that it shall be in the best interest of THE ZONEART LOUNGE, INC to elect James M. Dreher as a Director of The Zone Art Lounge, Inc. effective immediately.

As 100% share holder of The Zone Art Lounge, Inc. Jim Dreher, Inc. has determined that it shall be in the best interest of THE ZONEART LOUNGE, INC to remove Dustin Owen Dreher as a Director of The Zone Art Lounge, Inc. effective immediately.

The aforementioned minutes are a true and accurate reflection of the totality of issues and decisions discussed and made in The Zone Art Lounge, Inc. share holder's meeting held on this 17th day of December, 2004.

PLEDGE OF SHARES OF STOCK

BE IT KNOWN, for value received, the undersigned THE ZONE ART LOUNGE, INC. (a Florida Corporation.) (Pledgor) hereby deposits, delivers to and pledges with JIM DREHER, INC. (a Florida Corporation), (Pledgee) as collateral security to secure the payment of the following described debt owing Pledgee:

JIM DREEHR, INC. shall provide, or make arraignments to provide, the necessary down payment needed by THE ZONE ART LOUNGE, INC., to facilitate THE ZONE ART LOUNGE, INC.'s purchase of the property and improved structure located at 121-123 East Tarpon Avenue, Tarpon Springs, Florida 34689. In addition to said down payment, JIM DREHER, INC. agrees to provide THE ZONE ART LOUNGE, INC., with a temporary loan to provide financial support to THE ZONE ART LOUNGE, INC. for the first 30 days of operation after the closing date on the aforementioned property.

The shares of stock, described as 1000 shares of stock in THE ZONE ART LOUNGE, INC. represented as Stock Certificate No(s). 1 through 1000.

It is further agreed that:

- 1. The aforementioned shares currently represent 100% of the shares issued by THE ZONE ART LOUNGE, INC.
- JIM DREHER, INC., or a corporate representative acting in their official
 capacity as such, may assign or transfer said debt and the collateral pledged
 hereunder to any third party.
- 3. In the event a stock dividend or further issue of stock in THE ZONE ART LOUNGE, INC., is issued to the THE ZONE ART LOUNGE, INC, THE ZONE ART LOUNGE, INC. shall pledge said shares as additional collateral for the debt.
- 4. That during the term of this pledge agreement, and so long as it is not in default, THE ZONE ART LOUNGE, INC. shall have full rights to vote said shares and be entitled to all dividend income, except that stock dividends shall also be pledged.
- 5. That during the pendency of this agreement, THE ZONE ART LOUNGE, INC. shall not issue any proxy or assignment of rights to the pledged shares.
- 6. THE ZONE ART LOUNGE, INC. warrants and represents it has good title to the shares being pledged, they are free from liens and encumbrances or prior pledge, and THE ZONE ART LOUNGE, INC., has full authority to transfer said shares as collateral security.
- 7. Upon default of payment of the debt, or breach of this piedge agreement, JIM DREHER, INC., or holder shall have full rights to foreclose on the pledged

JIM DREHER, INC., or holder may have against THE ZONE ART LOUNGE, INC.

The Pledgor, THE ZONE ART LOUNGE, INC., understands that upon foreclosure the pledged shares may be sold at public auction or private sale. The Pledgor shall be provided reasonable notice of any intended sale and the Pledgor shall have full rights to redeem said shares at any time prior to said sale upon payment of the balance due hereunder, and accrued costs of collection. In the event the shares shall be sold for less than the amount then owing, the Pledgor shall be liable for any deficiency.

Upon payment of the obligation for which the shares are pledged, the shares shall be returned to the Pledgor and this pledge agreement shall be terminated

This pledge agreement shall be binding upon and inure to the benefit of the parties, their successors, assigns and personal representatives, in their official capacity as such.

Upon default the Pledgor shall pay all reasonable attorneys' fees and cost of collection.
