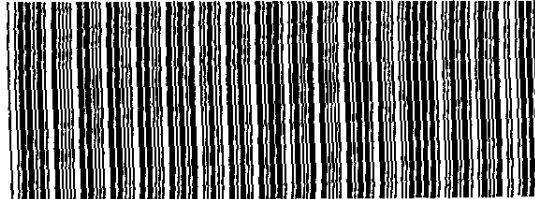

**CORPORATE NAME, PRINCIPAL OFFICE**  
**AND MAILING ADDRESS**

The name of this Corporation shall be: **KWK CONSTRUCTION, INC.**, with its principal office located at 2542 Brookline Avenue, New Smyrna Beach, Florida 32169 and its corporate mailing address being the same.

**ARTICLE II**


