

# ARTICLES OF INCORPORATION OF SEBRING AVIATION OF HIGHLANDS COUNTY, INC (a corporation for profit)

The undersigned, for the purpose of forming a corporation for profit under the provisions of the Florida Business Corporation Act, do hereby adopt the following Articles of Incorporation.

## ARTICLE I NAME

The name of this corporation is **SEBRING AVIATION OF HIGHLANDS COUNTY**, **INC**.

## ARTICLE II DURATION

This corporation shall have perpetual duration. The corporate existence shall begin with the date and time of the filing of these Articles of Incorporation by the Florida Department of State.

## ARTICLE III PURPOSES AND POWERS

This corporation is organized for the purpose of transacting any and all lawful business for which corporations may be incorporated under the Florida Business Corporation Act.

The corporation shall have all the rights, privileges and powers now or hereafter available to corporations for profit under the laws of the State of Florida.

#### ARTICLE IV CAPITAL STOCK

This corporation is authorized to issue 1,000 shares of \$1.00 par value common stock which shall be designated "common shares". Said stock shall be issued as "small business corporation" stock in accordance with the plan or plans under the provisions of Section 1244 of the Internal Revenue Code of 1954, as amended.

## ARTICLE V PRINCIPAL OFFICE

The address of the principal office is 1 Lockwood Lane, Sebring, Florida 33870, and the mailing address of the corporation shall initially be 1 Lockwood Lane, Sebring, Florida 33870.

#### ARTICLE VI INITIAL REGISTERED OFFICE AND AGENT

## ARTICLE VII MANAGEMENT OF THE CORPORATION'S AFFAIRS

All corporate powers shall be exercised by, or under the authority of, and the business and affairs of the corporation shall be managed under the direction of, the board of directors of the corporation.

### ARTICLE VIII OFFICERS

The officers of the corporation shall consist of a president, a secretary and a treasurer, and such other officers as may be authorized by the bylaws.
