OF

The undersigned, for the purpose of forming a corporation under the Florida Business Corporation Act here adopt the following articles of incorporation:

ARTICLE I  
NAME

The name of the corporation is FEINGOLD, INC.

DURATION

The term of existence of the corporation is perpetual.
