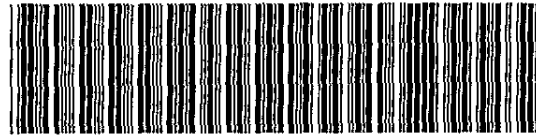

**ARTICLES OF INCORPORATION
OF
ATKINS LIFE-FORCE CHIROPRACTIC, INC.**

In compliance with the requirements of F.S. Chapter 607 and 621, the undersigned hereby acts as an incorporator in adopting and filing the following articles of incorporation for the purpose of organizing a business corporation.

ARTICLE I

The name of the Corporation is: Atkins Life-Force Chiropractic, Inc..

ARTICLE II

The existence of the Corporation shall begin on: November 5, 2004

ARTICLE III

The street address of the principal office of the Corporation is: 420 S.E. 18th Street, Ft. Lauderdale, Florida 33316.

ARTICLE IV

The specific purpose for which the Corporation is organized is:

1. To perform Chiropractic services.
2. To transact any other lawful business for which corporations may be incorporated under the Florida General Corporation Act, or engage into any other trade or business which can, in the opinion of the shareholders of the Corporation, be advantageously carried on in connection with and auxiliary to the foregoing business.
3. To do such other things as are incidental to the foregoing or necessary or desirable in order to accomplish the foregoing

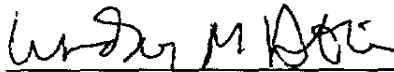

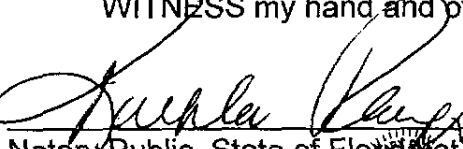

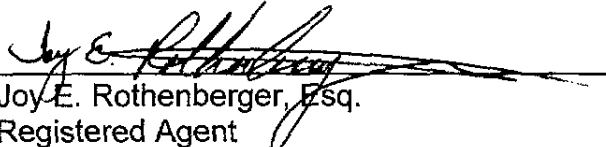
