Article One

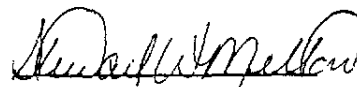

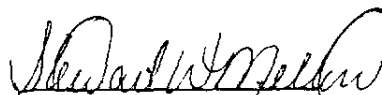
