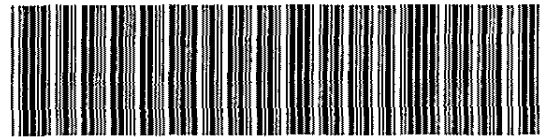

The undersigned, for the purpose of forming a corporation under the Florida General Corporation Act, Hereby adopts the following Articles of Incorporation.

ARTICLE ONE

The Corporate Name is: STEPHENSON PROCESS SERVICES, INC. The principal corporate address is: 3311 Imperial Lane, Lakeland, FL 33813.

ARTICLE TWO

DURATION

The term of existence of the Corporation shall commence January 1, 2005 and shall be perpetual.

The business of the Corporation shall be managed by a Board of Directors consisting of a minimum of one Director and a maximum of three directors.

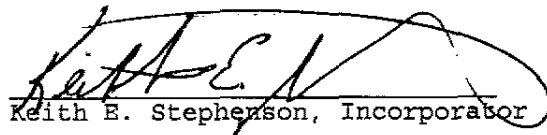
