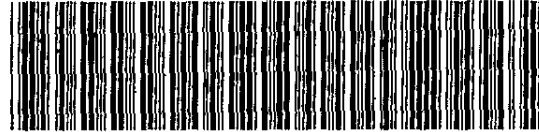

ARTICLE I. NAME.

The name of this Corporation is JENE'S BOBCAT AND CONSTRUCTION SERVICES, INC.

ARTICLE II. DURATION.

This Corporation shall have perpetual existence.
