THE UNDERSIGNED subscribers to these Articles of Incorporation, natural persons competent to contract, hereby form a corporation of profit under the laws of the State of Florida.

ARTICLE I - NAME AND PRINCIPAL PLACE OF BUSINESS

The name of the Corporation shall be ROAD RUNNER EXPRESS, INC. The principal place of business shall be located at 5923 60th Place East, Palmetto, FL 34221. The mailing address shall be 5923 60th Place East, Palmetto, FL 34221.

ARTICLE II - NATURE OF BUSINESS

The general character or nature of the business to be transacted by this Corporation is:
