ARTICLES OF INCORPORATION

OF

G & S Construction & Company, Inc.

ARTICLE I - NAME

The name of the corporation shall be:

G & S Construction & Company, Inc.

ARTICLE II - NATURE OF BUSINESS

The general nature of business to be transacted by the corporation and its objects and powers shall be as follows:

To perform all legal purposes and engage in the transaction of any and all lawful business for which corporations may be incorporated under the Florida General Corporation Act.

ARTICLE III - CAPITAL STOCK

The maximum number of shares of stock which this corporation is authorized to have outstanding at any one time is Five Hundred shares of common stock, having a par value of One Dollar per share. All stock issued by this corporation shall be fully paid and non-assessable and shall be transferrable only on the books of the corporation.

The whole or any part of the capital stock of this corporation shall be payable in lawful money of the United States of America, or property, labor, or services at a just valuation to be fixed by the Directors. Property or labor may also be purchased with the capital stock at such valuation as shall be fixed by the Directors or shareholders.

The shares of stock to be issued by the corporation shall be



subject to the following provisions and restrictions upon sales and transfer thereof.

In the event that a stockholder, by which term is included the executors, administrators, heirs

legatees and the nominee or personal representative of any stockholder shall desire to sell, assign, give or transfer, any shares of stock in the corporation, such stockholder must, by giving written notice of such desire to a majority of the Board of Directors, first afford to the corporation or the nominee or its Board of Directors the right and privilege for thirty (30) days to purchase the same at a price equal to a bonafide firm offer, in writing, made to each stockholder for the purchase of such share or shares of stock, by a person, firm or corporation ready, willing and able to buy such stock at the price so offered to be paid, and no stock of the corporation shall be transferred upon its books unless the foregoing provision has been complied with, and any attempt to transfer such stock in any other manner will be void.

ARTICLE IV - CAPITAL STRUCTURE

The corporation is authorized to issue only one class of stock, and all issued stocks shall be held of record by not more than 10 persons. Stock will be issued and transferred only to (1) natural persons, (2) estates, or (3) a trust as described in 26 USCS Section 1371 defining а qualified "small corporation". In addition, no stock shall be issued or transferred to a nonresident alien. This shall be a Sub-Chapter S corporation as defined by the Internal Revenue Service. These articles will be amended from time to time in order to comply with Internal Revenue Service rules and regulations with the sole purpose being to retain said status.

ARTICLE V - TERM OF EXISTENCE

This corporation shall have perpetual existence.

ARTICLE VI - PRE-EMPTIVE RIGHTS

Every shareholder, upon the sale for cash of any new stock of this corporation of the same kind, class or series as that which he already holds, shall have the right to purchase his pro-rata share thereof at the price at which it is offered to others.

ARTICLE VII - INITIAL PRINCIPAL OFFICE AND REGISTERED AGENT

The street address of the principal office of this corporation is 3755 11th.St., Micco, FL 32976, and the name of the initial registered agent of this corporation is Richard R. Giguere.

ARTICLE VIII - INCORPORATOR

The name and address of the person signing these articles as incorporator is:

ARTICLE IX - BY-LAWS

The power to adopt, alter, amend or repeal by-laws shall be vested in the Board of Directors and the shareholders.

ARTICLE X - AMENDMENT OF ARTICLES

This corporation reserves the right to amend or repeal any provisions contained in these Articles of Incorporation, or any amendment hereto, and any right conferred upon the shareholders is subject to this reservation.

ARTICLE XI - INITIAL BOARD OF DIRECTORS

The names and post office addresses of the first Board of Directors and officers of the corporation, who, subject to the provisions of this Certificate of Incorporation, and the By-Laws and General Corporation Law of the State of Florida, shall hold

office for the first year of the Corporation's existence or until their successors are elected and have qualified, are as follows:


