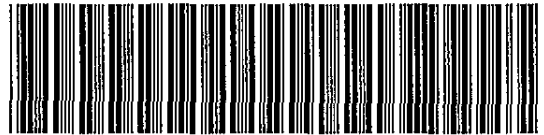


XIII


