#### ARTICLES OF INCORPORATION

OF

Pursuant to the provisions of Chapter 607, Florida Statutes, this Corporation adopts the following articles of incorporation:

# ARTICLE I - NAME OF CORPORATION:

The name of the corporation shall be SOUTHSTAR LAND EDWARDS ROAD, INC.

The number of shares of stock that this corporation is authorized to have outstanding at any one time is: 100 chares of common stock having a par value of \$1.00 per share.

### ARTICLE IV - INITIAL DIRECTORS AND OFFICERS:

There shall be two (2) directors, initially. The number of Directors may be increased, and after such increase, decreased from time to time by bylaws adopted by the shareholders. #### ARTICLE Y - INDEMNIFICATION:

Any person who was or is a party, or is threatened to be made a party to any threatened, pending, or completed action, sult, or proceeding, whether civil, criminal, administrative, or investigative, and whether or not brought by or in the right of the corporation, by reason of the fact that he or she is or was a director, officer, employee, or agent of the corporation, or is or was serving at the request of the corporation as a director, officer, employee or agent of another corporation, partnership, joint venture, trust, or other enterprise, shall be indemnified by the corporation (unless the conduct of such person is finally adjudged to have been grossly negligent or to constitute willful misconduct), against expenses, including attorneys' fees, judgments, fines, and amounts paid in settlement actually and responsity incurred by him or her in connection with such action, sult, or proceeding including any appeal thereof. Expenses (including attorneys' feas) incurred in defending a civil or priminal action, suit, or proceeding shall be paid by the corporation in advance of the final disposition of such action, suit, or proceeding upon receipt of an undertaking by or on behalf of the director, officer, employee or agent to repay such amount, unless it shall ultimately be determined that he or she is entitled to be indemnified by the corporation as authorized by this Article. Indemnification heraunder shall continue as to a person who has ceased to be a director, officer, employee or agent, and shall inure to the benefit of the heirs, executors, and administrators of such person. The foregoing rights of indemnification shall not be deemed exclusive of any other rights to which any such person may otherwise be entitled apart from this Article.

## ARTICLE VI - BYLAWS:

The power to adopt, after, amend or repeal bylaws shall be vested in and is heraby reserved to the shareholders. Bylaws shall be adopted, aftered, amended or repealed as provided therein.
