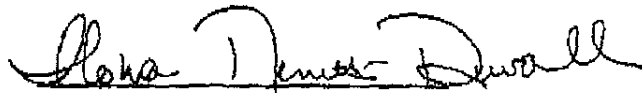
ARTICLE IX

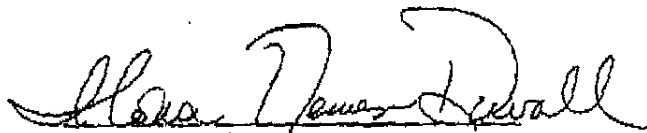

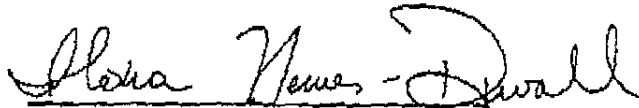
