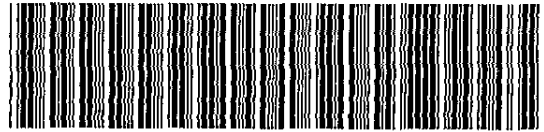

**AMENDED FINAL JUDGMENT IN FAVOR OF PLAINTIFF AND AGAINST  
DEFENDANTS HAGEMEYER NA & TRISTATES, INC., JACQUELYN MOULTRIE,  
CLARIBETH VALENCIA AND BAMIDALE T. JOHNSON**

This matter came to be considered by the Court on the date indicated below upon the representation to the Court by Plaintiff Hagemeyer North America, Inc. that Defendant Claribeth Valencia, who is the only defendant with standing to object to entry of this judgment, has consented to the entry of this judgment, and the Court being otherwise duly advised in the premise,

ADJUDGES as follows:

(1) That Defendants Hagemeyer N.A. and Tristates, Inc., Jacquelyn Moultrie, and Bamidale T. Johnson are in default for failing to serve or file any paper in response to Plaintiff's Complaint.

(2) That Plaintiff Hagemeyer North America, Inc. is entitled to the relief sued for in the Amended Complaint as and against Defendants Hagemeyer N.A. and Tristates, Inc., Jacquelyn Moultrie, Claribeth Valencia, and Bamidale T. Johnson (the "Judgment Debtors").

(3) That upon counts I, II, III, V, VI, and VII of the Amended Complaint, Plaintiff Hagemeyer North America, Inc. does have and shall recover of and from the Judgment Debtors the sum of \$293,607.82<sup>1</sup> as and for principal, plus \$20,552.55 for post-judgment interest at 7% on said principal, plus \$64,145.27 as and for attorneys' fees and costs from March 28, 2005 through April 30, 2006, making a total sum of \$378,305.64 due as of April 30, 2006 (the "Judgment Debt"), for which total sum let execution issue forthwith.

✓ (4) That upon count III, the Secretary of State of Florida shall revoke and/or dissolve the corporate status of "Cameron and Barkley, Inc."; "The Hagemeyer Corporation"; "Hagemeyer Americas, Inc."; and "Hagemeyer N.A. & Tristates" pursuant to Section 895.05(e), Florida Statutes, and the Judgment Debtors shall take any and all action required by the Florida Secretary of State to accomplish the aforementioned relief.

(5) That upon count III, the Secretary of State of Nevada shall revoke and/or otherwise permanently dissolve the corporate status of "Hagemeyer North American & Tristates, Inc.", and the Judgment Debtors shall take any and all action required by the Nevada Secretary of State to accomplish the aforementioned relief.

(6) That the permanent injunctive relief awarded through the orders of the Court dated January 14, 2005, January 19, 2005, and July 12, 2005 shall remain in force.

(7) Jurisdiction of this action is retained to enter such further orders and declarations that are proper, including, without limitation, (a) the amount to be awarded Plaintiff for

reasonable attorneys' fees and costs incurred on and after May 31, 2006 (including attorneys' fees and costs incurred in enforcing this judgment), and (b) disposition of any property, monies, accounts, etc., held or restrained by any defendant.

(8) This judgment shall bear interest at the rate prescribed by Florida law.

(9) The last known address of defendant Jacqueline Moultrie and defendant Hagemeyer N.A. & Tristates, Inc., is 248 Washington Avenue, #C, Miami Beach, Florida 33139. Defendant Moultrie's social security number is unknown, but may be 216-78-7282.
