# ARTICLES OF INCORPORATION

OF

#### ARTICLE 1 - NAME

The name of the corporation is East Coast Auto Transport of Brevard, Inc., at 882 Grandur Street, Palm Bay, FL 32909 (Principal Office of Registered Agent).

#### ARTICLE II - DURATION

This corporation shall exist perpetually, commencing at the time of filing these articles with the Secretary of State of the State of Florida.

#### ARTICLE III - PURPOSE

This corporation is organized for the purpose of transacting any of all lawful business.

#### ARTICLE IV - CAPITAL STOCK

This corporation is authorized to issue 500 shares of One Dollar (\$1.00) par value common stock, which shall be designated "Common Shares".
