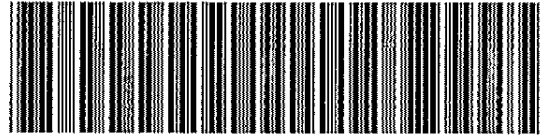
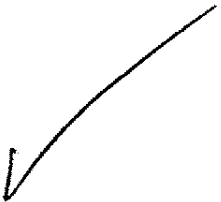

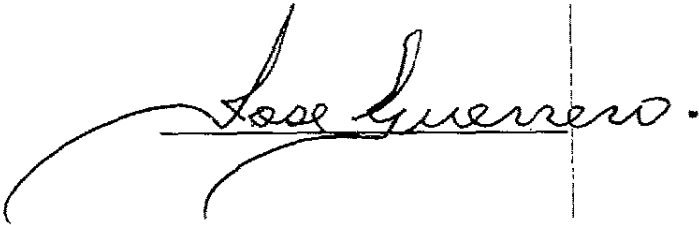
ARTICLE VIII - INDEMNIFICATION

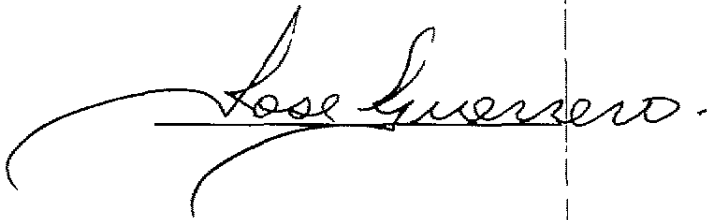
