The undersigned subscriber Christopher J. Stanley, a natural person competent to contract, hereby forms a corporation under the laws of the State of Florida, and adopts the following Articles of Incorporation:

ARTICLE I - NAME

The name of the corporation shall be SEA SECTION, INC.

ARTICLE II - PRINCIPAL PLACE OF BUSINESS
