



ARTICLE I.

NAME

The name of the Corporation shall be RASER, CORP.



ARTICLE II.

PRINCIPAL OFFICE

The principal place of business and mailing address of this Corporation shall be: 1035 94th. STREET SUITE 6, BAY HARBOR ISLANDS, FL. 33154

ARTICLE III.

PURPOSES

The purpose for which the corporation is formed and the business and objects to be carried on and promoted by it are as follows:

INSPECTION OF BOOKS AND RECORDS
