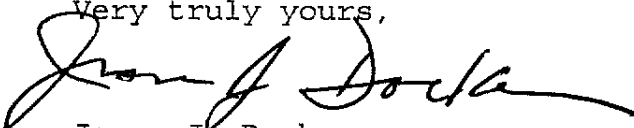

Articles of Incorporation

SUMMIT CONSENSUS GROUP, INC.

The undersigned, for the purpose of forming a corporation under the provisions of the FLORIDA GENERAL CORPORATION ACT, do hereby adopt the following Articles of Incorporation:

ARTICLE I

The name of the corporation is SUMMIT CONSENSUS GROUP, INC.

ARTICLE II

The duration of the corporation is perpetual.

ARTICLE III

The corporation may engage in the operation of an enterprise dedicated to the collection of information and data through polling and survey and the dissemination of said information and data by any means or medium or to enter into any other business activity authorized under the laws of the State of Florida or of the laws of the United States.

ARTICLE IV

The Corporation shall have authority to issue one (1) class of Capital Stock, which shall consist of one million (1,000,000) shares of one dollar (\$1.00) PAR value Common Stock.

ARTICLE V

The corporation shall commence business upon receipt of the Articles of Incorporation by the Secretary of State of the State of Florida.

ARTICLE VI

The principal place of business shall be located in LEE COUNTY, FLORIDA. The address of the principal place of business shall be 1426 SE 44th Street, Cape Coral, Florida. The corporation shall have the right and authority to transact business at such other place or places within or without the State of Florida as the corporation may by resolution designate.

ARTICLE VII

The corporation shall have a board of directors consisting of no less than one (1) nor more than five (5) members. The number of said directors shall be determined by the shareholders at their annual meeting or may be fixed by the By-laws of the corporation.

ARTICLE VIII

The officers by whom the business of said corporation shall be conducted shall be the President, who shall be a Director, the Secretary and Treasurer and other such officers and agents who shall be chosen by the Board of Directors. Each officer shall hold office for such term and have such powers and duties as may be prescribed by the By-laws or determined by the Board of Directors. The initial Board of Directors shall consist of one (1) member and shall act as director until successors are elected and qualified. ARTICLE X

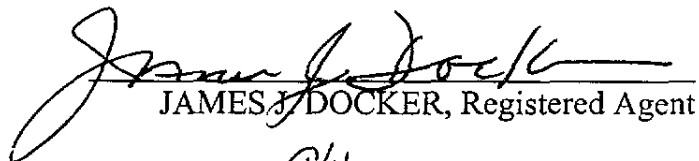

ARTICLE XI

The Stockholders shall adopt the initial By-laws of this corporation. The By-laws may be amended from time to time by either the stockholders or the Board of Directors. The shareholders shall have the final vote as to the adoption or changes made to the By-laws.

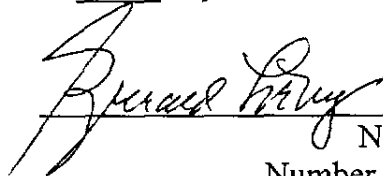
