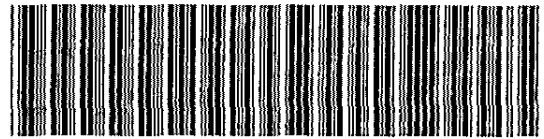

ARTICLES OF INCORPORATION
OF

The undersigned, desiring to form a professional corporation in accordance with Chapter 621 of the Florida Statutes and the Professional Service Corporation And Limited Liability Company Act, adopts the following Articles of Incorporation:

Article 1 - Name.

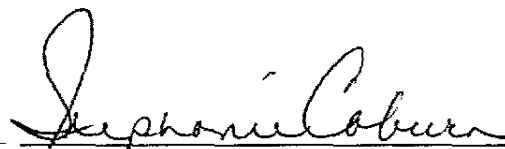
Article 8 - Effective Date.

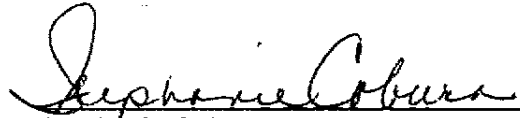
