ARTICLE I

Name and Duration

The name of the Corporation is Cardiac Rhythm Technologies, Inc. The duration of the Corporation is perpetual. The effective date upon which this Corporation shall come into existence shall be the date these Articles are filed by the Secretary of State.

ARTICLE II

Principal Office

The street address of the principal office and mailing address of the Corporation is 1333 North Duval Street, in the City of Tallahassee, County of Leon, 32303.

ARTICLE III

Registered Office and Agent

The address of the registered office in the State of Florida is 1333 North Duval Street, in the City of Tallahassee, County of Leon, 32303. The name of the registered agent at such address is Corporate Research Solutions, Inc.

ARTICLE IV

Corporate Purposes, Powers and Rights

1. The nature of the business to be conducted or promoted and the purposes of the Corporation are to engage in any lawful act or activity for which corporations may be organized under the Florida Business Corporation Act.

2. In furtherance of its corporate purposes, the Corporation shall have all of the general and specific powers and rights granted to and conferred on a corporation by the Florida Business Corporation Act.

2. If any vacancy occurs in the Board of Directors during a term, the remaining directors, by affirmative vote of a majority thereof, may elect a director to fill the vacancy until the next annual meeting of shareholders.
