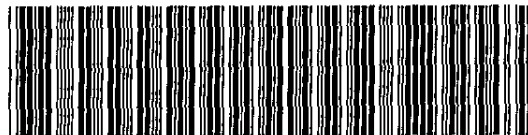

ARTICLE I - NAME AND PRINCIPAL ADDRESS

The name of the corporation is TELECOM SYSTEM SOLUTIONS NT, INC., and the principal address and principal place of business is 3135 39<sup>TH</sup> AVENUE NORTH, SUITE 1A, ST. PETERSBURG, FLORIDA 33714.

ARTICLE II - REGISTERED OFFICE AND AGENT

#### ARTICLE VI - AMENDMENTS


