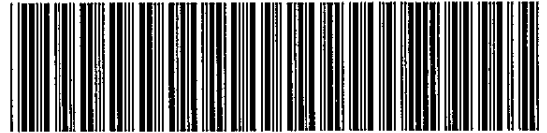

ARTICLES OF INCORPORATION

OF

EMPIRE CABINETRY, INC.

ARTICLE I - NAME

The name of this corporation is EMPIRE CABINETRY, INC.

ARTICLE II - DURATION

This corporation shall exist perpetually.




