ARTICLES OF INCORPORATION OF SONRISE BUILDERS, INC.

The undersigned, acting as incorporator (s) to form a corporation under the Rorida General Corporation Act, adopt the following Articles of Incorporation for such corporation.

ARTICLE I. NAME

The name and address of this corporation is: SONRISE BUILDERS, INC., 30830 Cherokee Avenue, Leesburg, Florida 34748.

ARTICLE II. NATURE OF BUSINESS

This corporation may engage in any activity or business permitted under the laws of the United States and the Sate of Florida.

ARTICLE III. CAPITAL STOCK

The maximum number of shares of stock that this corporation is authorized to have outstanding at any one time is 7,500 shares of common stock, having a nominal or par value of \$1.00 per share.
