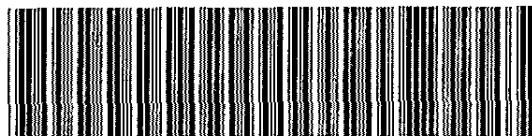

ARTICLES OF INCORPORATION

OF

211 E. BAY STREET, INC.

ARTICLE I

NAME

The name of this corporation is 211 E. Bay Street, Inc.

ARTICLE II

NATURE OF BUSINESS

This corporation is organized for the purpose of engaging in and transacting any and all lawful business permitted under the laws of the State of Florida or any other state and of the United States.

ARTICLE III

CAPITAL STOCK

that such By-Laws shall not be altered, repealed or amended by the Board of Directors.


