

ARTICLES OF AMENDMENT OF TROY SEAFOOD MARKET RESTAURANT & RAW BAR, INC.

Pursuant to the provisions of Section 607.1006 of the Florida Business Corporation Act, the undersigned corporation adopts the following Articles of Amendment of its Articles of Incorporation:

1. Article I of the Articles of Incorporation of Troy Seafood Market Restaurant & Raw Bar, Inc., is hereby amended to read:

The name of this corporation is TROY SEAFOOD RESTAURANT & RAW BAR, INC.

The foregoing Amendment was adopted by the shareholders of this corporation under Sections 607.0704 and 607.1003(6), Florida Statutes, by written action on the 3rd day of January 2005.

The corporation has fewer than thirty-five (35) shareholders and currently has one hundred issued and outstanding shares of stock. The owners of one hundred shares (100) representing all of their one hundred shares (100), signed the written action adopting this Amendment to the Articles of Incorporation.

There are no separate voting groups and no other voting group is entitled to vote separately. The number of votes cast were sufficient for approval.
