ARTICLES OF INCORPORATION

OF

VILLA CITRUS OF CENTRAL FLORIDA, INC.

CHED OF STATES

The undersigned, for the purpose of forming a corporation under the Florida General Corporation Act, does hereby adopt the following articles of incorporation:

ARTICLE ONE

The name of the corporation is VILLA CITRUS OF CENTRAL FLORIDA, INC.

ARTICLE TWO

The duration of the corporation is perpetual.

ARTICLE THREE

The general purpose for which the corporation is organized is any business authorized by Florida Statutes and permitted by law.

ARTICLE FOUR
