ARTICLES OF INCORPORATION

OF

FRED LECHER, D.P.M., P.A.

The undersigned, who is duly licensed to practice medicine in the State of Florida, desiring to form a professional corporation in accordance with Chapter 621 of the Florida Statutes, adopts the following Articles of Incorporation:

ARTICLE I

NAME: The name of the corporation shall be FRED LECHER, D.P.M., P.A. The principal office address shall be 411 South Orange Street, New Smyrna Beach, Florida 32168.

ARTICLE II

DURATION: This corporation shall have a perpetual existence.

ARTICLE III

PURPOSE: The purpose for which the corporation is organized is to perform podiatry medical services to the general public.

ARTICLE IV

CAPITAL STOCK: The number of shares of stock which the corporation is authorized to have outstanding is \$100.00, all of which shall be common shares with a par value of \$5.00 per share.

ARTICLE V

CAPITAL: The amount of stated capital with which the corporation shall begin business is Five Hundred Dollars (\$500.00).

ARTICLE VI

REGISTERED OFFICE: The address of the initial registered office in this state is Florida, and the name of the initial registered agent at said address is FRED LECHER, D.P.M., 411

South Orange Street, New Smyrna Beach, Florida 32168, who by his signature hereon accepts such designation.

ARTICLE VII

INCORPORATOR: The name and address of the Incorporator is: FRED LECHER, D.P.M., 411 South Orange Street, New Smyrna Beach, Florida 32168.

ARTICLE VIII

DIRECTORS: Initially, the corporation shall have a Board of Directors consisting of one (1) Director, whose name and address is as follows:

ARTICLE IX

INFORMAL SHAREHOLDER ACTION: Any action of the Shareholders may be taken without a meeting if consent in writing setting forth the action so taken shall be signed by all the Shareholders entitled to vote upon such action at a meeting and filed with the Secretary of the corporation as part of the corporate records.

ARTICLE X

SEVERANCE AND TERMINATION OF EMPLOYMENT: If any officer, director, stockholder, agent or employee of this corporation becomes legally disqualified to render the professional services for which the corporation is organized, or accepts employment that places restrictions or limitations on his continued rendering of such professional services, he shall forthwith sever all employment with the corporation, and shall not thereafter participate or share, directly or indirectly, in any earnings or profits realized

by the corporation on account of professional services. The corporation shall forthwith, upon such disqualification of any shareholder, purchase such shareholder's shares and pay him all amounts owing and lawfully due to him by the corporation, except that such shares shall not be entitled to dividends.

ARTICLE XI

INFORMAL DIRECTOR ACTION: If all of the Directors severally or collectively consent in writing to any action taken or to be taken by the corporation, and the writings evidencing their consent are filed with the Secretary of the corporation, the action shall be as valid as though it had been authorized at a meeting of the Board of Directors.

ARTICLE XII

INDEMNIFICATION: The corporation shall indemnify any officer or director, or any former officer or director, to the full extent permitted by law.

ARTICLE XIII

BYLAW AMENDMENT: The power to adopt, alter, amend or repeal the bylaws of this corporation shall be vested in the Board of Directors and Stockholders provided that such amendment be in compliance with the laws of Florida governing a Professional Service Corporation.
