ARTICLE I-NAME

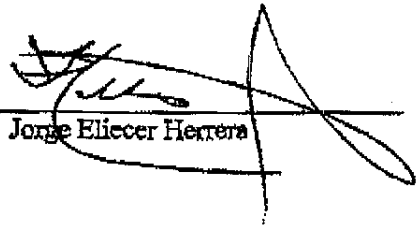
ARTICLE X-INCORPORATOR
