ARTICLES OF INCORPORATION

OF

SECRETARY OF STATE TALLAHASSET TO ORIDA

ANSUKI CLEANING AND SWEEPING SERVICES CORPORATION

We, Antonio Chamorro and Esteber Jaimes, the undersigned, hereby execute these Articles of Incorporation for the purpose of becoming a corporation under the laws of the State of Florida, by and under the provisions of the Statutes of the State of Florida providing for the formation, rights, privileges, immunities and liabilities of corporation non profit.

ARTICLE I

The name of the corporation is: <u>ANSUKI CLEANING AND SWEEPING</u> SERVICES CORPORATION.

ARTICLE II

The general nature of the business to be conducted shall be: The corporation may engage in activity or business permitted under the laws of the United States of America and the State of Florida.

ARTICLE III
