The undersigned hereby adopt the following Articles of Incorporation for the purpose of forming a corporation under the laws of the State of Florida:

ARTICLE I: NAME

The name of the corporation is Piayo, Inc.

ARTICLE II: DURATION

The corporation is to commence its corporate existence on the date of filing of the Articles of Incorporation and shall exist perpetually thereafter until dissolved according to law.

ARTICLE III: PURPOSE


