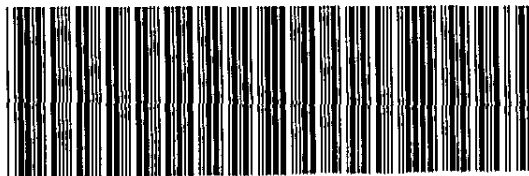

ARTICLE I - NAME

The name of this corporation is Manufacturing Engineering Consultants, Inc.
