The undersigned Incorporator hereby forms a corporation under the laws of  
the State of Florida.

**ARTICLE I. CORPORATE NAME**

The name of the Corporation is:

**ARTICLE III. CAPITAL STOCK**

The aggregate number of shares of stock that this Corporation is authorized
