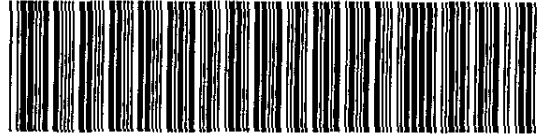

ARTICLES OF INCORPORATION

OF

LAW OFFICES OF LISA BISAGNI, P.A.

Article I - NAME

The name of the corporation shall be Law Offices of Lisa Bisagni, P.A.

Article II - PRINCIPAL OFFICE
