**ARTICLES OF INCORPORATION
OF
CENTER FOR FILIPINO-AMERICAN GOVERNMENT ADVOCACY, INC.**

The undersigned natural person, acting as incorporator of a corporation under the Florida Business Corporation Act, adopts the following Articles of Incorporation for such Corporation.

ARTICLE I:

Name

The name of the Corporation shall be CENTER FOR FILIPINO-AMERICAN GOVERNMENT ADVOCACY, INC.

**ARTICLE II:
Principal Office**

Duration

The duration of the Corporation shall be perpetual.

ARTICLE IV:

Purpose

The specific purpose or purposes for which the Corporation is organized are:

1. To champion Filipino-American causes in government including legislative, judicial and executive branches of the government and to develop and promote active leadership of Filipino-American in affairs of the government.
2. To demonstrate to the community and the nation at large that Filipino-American voters have significant impact on political affairs.
3. To be cognizant of existing government laws and proposed changes in legislation that will impact Filipino-American in the different communities in the State of Florida and in the United States.

ARTICLE V:

Capital Stock

The aggregate number of shares which the Corporation shall be authorized to issue is 10,000 consisting of one class only, designated as "Common Stock," with a par value of \$0.05 per share.






