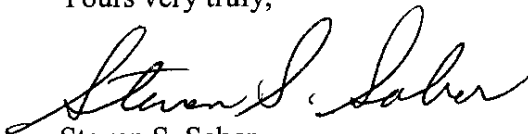
I also never received an Annual Report renewal notice for 2005.
