

ARTICLES OF INCORPORATION

OF

JemTrek Corp.

ARTICLE I - NAME and PRINCIPAL PLACE OF BUSINESS

The name of this corporation is JemTrek Corp. and its principal place of business shall be located at 2649 Stanmore Court, Orlando, FL 32817.

ARTICLE II - DURATION

This corporation shall have perpetual existence commencing on the date of this filing of these Articles of Incorporation with the Department of State.

ARTICLE III - PURPOSE

This corporation is organized for this purpose of transaction any or all lawful business.

ARTICLE IV - CAPITAL STOCK

Initially, this corporation shall have two (2) directors, who shall serve until their successors shall be elected at the first meeting of the stockholders and thereafter this corporation shall have no less than two (2) directors constituting the Board of Directors.
