ARTICLES OF INCORPORATION

OF

The undersigned, duly licensed to practice law under the laws of the State of Florida, and for the purpose of forming a corporation under the Florida Professional Service Corporation and Limited Liability Company Act, F.S. Chapter 621, adopts the following Articles of Incorporation:

ARTICLE I NAME
