ARTICLE 1

NAME

The name of this Corporation is STEPHEN M. NEWMAN, P.A. (the "Corporation").

INCORPORATOR

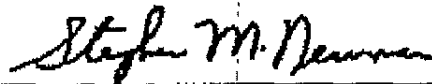
