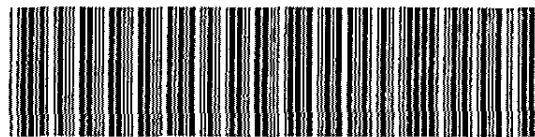

The undersigned, being a natural person of the age of more than twenty-one (21) years, does hereby act as incorporator in adopting the following Articles of Incorporation for the purpose of organizing a business corporation pursuant to the provisions of the Florida Business Corporation Act.

FIRST: The names of the corporation ("Corporation") shall be Ed Lauramore Trucking, Inc.

The principal place of business of this corporation shall be 1144 Owen Avenue, Jacksonville, Florida 32205.

SECOND: The effective date of these Articles of Incorporation shall be January 1, 2005.

THIRD: The duration of the corporation shall be perpetual.

FOURTH: The purposes for which the Corporation is organized, which shall continue to be the purposes of the Corporation until and if the same be amended pursuant to the provisions of the Florida Business Corporation Act, and which shall include the authority of the Corporation to transact any lawful business for which a corporation may be incorporated under the Florida Business Corporation Act, are as follows:

A. To have all of the powers conferred upon corporations organized under the Florida Business Corporation Act.

FIFTH: The aggregate number of shares which the Corporation shall have the authority to issue is One Hundred (100), all of which are of a par value of One dollar (\$1.00) and each of which are to be common shares of the same class.

Each share of stock, regardless of class, shall share equally in the distribution of assets of the Corporation with no preference other than as to the election of directors residing in any class of stock.

SIXTH: The address of the initial registered office of the Corporation in the State of Florida is 144 Owen Avenue, Jacksonville, FL 32205, and the name of the initial registered agent of the Corporation at such address is Patricia A. Lauramore.

SEVENTH: The manner in which the directors of the Corporation shall be elected shall be contained in the Bylaws of the Corporation.

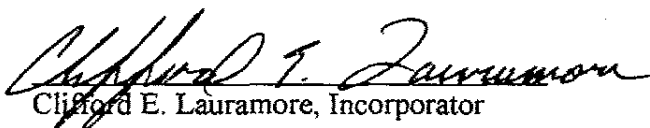

NINTH: The Corporation shall, to the fullest extent permitted by the provisions of the Florida Business Corporation Act, as the same may be amended and supplemented, indemnify any and all persons whom it shall have the power to indemnify under said provisions from and against any and all of the expenses, liabilities, or other matters referred to in or covered by said provisions, and the indemnification provided for herein shall not be deemed exclusive of any other rights to which those indemnified may be entitled under any Bylaw, agreement, vote of disinterested directors, or otherwise, both as to such person's action in such person's official capacity while holding such office, and shall continue as to a person who has ceased to be an officer or director, and shall inure to the benefit of the heirs, executors, and administrators of such a person.

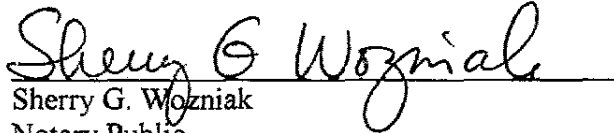

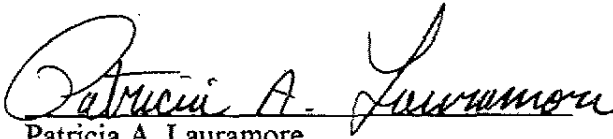

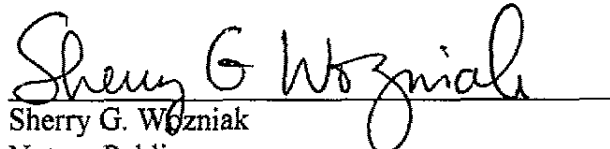
